



Remote Learning Care Agreement

Celebration! Childcare is offering a full day care option for families with working parents whose child's school district is only providing a remote learning option this fall. Please see the following information as to how and what Celebration! Childcare will help support you and your child during these times.

- Celebration! Childcare will be providing a quiet space for your child to complete their remote learning on their own.
- Our staff will not be responsible for teaching your child their lessons or tutoring them in any way.
- Our staff will be responsible for making sure your child stays on task and is able to log onto their programs.
- It is the parents' responsibility to provide Celebration! Childcare with their child's remote learning schedule, materials they will need, and any additional items to facilitate your child with their schooling. Included in these provided materials would be a device that the school district has supplied or recommended, charging cord and headphones.
- Celebration! Childcare will provide a report at the end of the day, if applicable, on what your child completed for the day and if any additional work needs to be done.
- In the event that our WIFI service experiences technical issues, a phone call will be made to the parent to inform them. The parent would need to let the child's school and teacher know what is going on.

Celebration! Childcare WILL:

- Offer full day care for your school-age child due to remote learning
- Designate select hours of remote learning time based on your child's school district schedule and policy
- Provide 2 snacks and a lunch
- Monitor your child during his/her scheduled remote learning time
- Provide your child with a quiet and safe space to work on their school work
- Offer your child access to socialization and outdoor activities, as their schedule permits
- Continue to follow COVID-19 procedures set in place by our facility, DCFS, and the local health department
- Follow DCFS guidelines and licensing standards
- Communicate with parents on any issues, concerns, or obstacles your child is having during remote learning

Celebration! Childcare WILL NOT:

- Teach, assist, or be responsible for your child's learning
- Provide tablets or computers for remote learning. Each family will be required to provide all remote learning necessities (charging cords and headphones)
- Be held responsible for any lost, stolen, or damaged items that occur while your child is in attendance
- Be responsible for technical issue with electronics, WIFI, or any other occurrence that may hinder your child's completion of their remote learning
- Be communicating with the school or your child's teacher about their progress or concerns.
- Be responsible for incomplete or incorrect assignments

Parent Responsibilities:

- Provide at least a device, charger and headphones for your child. Any other school requested materials must also be provided by the parents
- Provide information from your child's school outlining the remote learning schedule and expectations
- Accept and adhere to the COVID-19 procedures developed by Celebration! Childcare as well as the DCFS licensing standards
- Provide 2 masks for your child

Safeguards For Tech Equipment:

- Equipment will travel to and from the facility with the student
- Parents will acknowledge responsibility to ensure the equipment is in working order
- Parents will provide charging cord for electronics
- Only the owner of the tech equipment will be allowed to use the device
- Devices will be sanitized upon entering the building and after being used
