## **CONSENT FORM**



**PHOTO CONSENT:** I authorize Celebration! Childcare to take pictures, slides and videos of my child for use in presentations and other educational type activities, including occasional publication on the Holy Cross website/newsletter. No personal identifiable information will be used.

**EMERGENCY PROCEDURES:** I give permission to Celebration! Childcare to take whatever emergency measures are judged necessary for the care and protection of my child while under the supervision of the center. In case of medical emergency, I understand that my child will be transported to the nearest facility deemed by the local emergency unit for treatment, at my expense. It is understood that in some medical situations staff will need to contact the local resource before the parent/guardian.

**CONFIDENTIALITY OF INFORMATION:** Celebration! Childcare will not release information on any child or child's family enrolled in the center without the parental approval, except to the Department of Child and Family Services (DCFS) as requested by the Licensing Representative.

## **TUITION POLICY:**

**Celebration! Childcare:** Tuition in the amount agreed upon in your contract is due the first day of the week that your child attends. There is no deduction for absence or Holidays within the week. You will be asked to withdraw from the center if your account becomes two weeks past due.

**RELIGION CONSENT:** I understand that in addition to socialization and pre-kindergarten readiness skills, the Celebration! Childcare program has a Christian component. This may include regular pastor visits and Chapel time, simple prayers, and Bible stories and songs.

**WALKING FIELD TRIPS:** I give my permission to Celebration! Childcare to take my child for daily walks. I need not be notified of these walking field trips.

**RELEASE OF ADDRESS, PHONE, and E-MAIL:** I authorize that my address, phone number and email address may be released to other Celebration! Childcare parents/staff. I understand that this information is not to be used for any solicitation purpose.

**INTEGRATED PEST MANAGEMENT:** I understand that Celebration! Childcare will notify me two business days prior to and not more than thirty days in advance of any pesticide applications made at the school. This includes insecticides, herbicides, rodenticides and fungicides but does not include antimicrobial agents, insecticide baits, and rodenticide baits.

**BEHAVIOR POLICY:** In the event that a child's behavior progresses to the point that he/she poses a threat to him/herself, the other children enrolled in the center, or staff members and after the use of appropriate discipline (based on the child's age and development) have proven unsuccessful in protecting the environment of the center, the parent/guardian of the child will be contacted and must remove the child from the center for the remainder of the day. Repeated behavioral problems could result in disenrollment. I have received a copy of the parent-handbook.
